Dear Mr. Giacometti,

I stayed at the Four Seasons Hotel Cairo at Nile Plaza on January 25 and 26, 2025. I appreciate your kindness in allowing me to stay at the Four Seasons Hotel Cairo at Nile Plaza and to give a comment to you, as I did at Osaka University, on January 26, 2025.

Mr. Yves Giacometti: General Manager of the Four Seasons Hotel Cairo at Nile Plaza (January 26, 2025)

Dr. Shida provides an explanation to Mr. Giacometti

This is my second visit to Cairo since my first trip in 1997.

From 1990 to 1994, I had the honor of serving as a part-time "Team Doctor for the All-Japan Table Tennis Team." However, from 1990, I was subjected to various forms of harassment by doctors affiliated with the *San-ikai* (an academic clique within the Mie University School of Medicine) while I was enrolled at the National Mie University Graduate School of Medicine, working at Mie University Hospital, and at other Mie University-affiliated hospitals in Mie Prefecture in Japan.

For example, at a hospital ward nurse station, an Assistant Hospital Director (*San-ikai*) with a blank patient chart arrogantly shouted at me, "Why don't you fill out the patient's chart properly?" while poking me on the shoulder, and the surrounding *San-ikai* physicians merely stood by, laughing without intervening. Subsequently, my salary was reduced by half, and ultimately, after I pointed out issues regarding the medical care and research conducted by Dr. Masahiko KAITO (then Lecturer, now Professor) at National Mie University of the *San-ikai* and the Hepatology Group at domestic academic conferences, I was effectively dismissed.

Moreover, I was informed by the hospital director of the National Mie University Hospital at the time (a graduate of Tohoku University) and the professor of the Third Department of Internal Medicine at Mie University (a *San-ikai* member), "The *San-ikai* physicians and the hospital director of a hospital in Mie Prefecture, where I worked, are trustworthy because they passed the entrance examinations for national university medical schools, such as Kumamoto University. In contrast, although you graduated from the National Mie University Graduate School of Medicine, you only passed the entrance examination for the Faculty of Education at National Fukushima University, so you are not trustworthy."

Under such intense pressure, I was unfortunately unable to afford medical textbooks or attend academic conferences, which prevented me from obtaining certification as an internal medicine specialist. Consequently, my academic papers for the Japan Table Tennis Association were far from commendable. Additionally, there were serious issues concerning inappropriate interpersonal relationships between men and women at the workplace of Dr. Osamu TAGUCHI, who was then a lecturer and is now a professor at National Mie University.

After being effectively dismissed from a hospital in Mie Prefecture in 1997, I registered with "Hello Work" (Public Employment Security Office; the equivalent organization in America is the "American Job Centers"). Using approximately 300,000 yen (2,500USD, Approximately 120 yen per USD in 1997). After receiving unemployment insurance, I took a sightseeing trip to Cairo in the summer before starting my new job at a clinic in Osaka in September 1997, where I had the pleasure of meeting the Sphinx—"Hello, Majestic Sphinx."

I first visited the interior of the Great Pyramid of King Khufu in August, 1997. On my way back from the King's Chamber, while passing through the ascending passage that continues from the Grand Gallery, I saw a Western family emerging from the passage leading to the Queen's Chamber, which was separated by a fence. They were handing cash to an Egyptian guide. The Egyptian guide confirmed the amount of money on the spot and said to the family, "No problem."

From the perspective of my area of expertise—university entrance examination fraud—this situation academically overlaps with the backdoor admissions of third-rate private universities in Japan. Even in private money-powered backdoor universities like Aichi Medical University, Teikyo University, Tokyo Medical University, and Tokyo Women's Medical University, illegal entrance examination brokers and under-the-table money circulate almost without being reported by the mass media.




Dr. Shida encountered "Hello, Majestic Sphinx" once again on January 25, 2025

Egyptian newspapers and TV stations may not report on the "backdoor access" to the Queen's Chamber of the Great Pyramid of Khufu as it might be considered legal. However, this situation indicates no difference from Japan's mass media and Asahi Shimbun, which act as sycophants ("taikomochi") for private institutions like Fujita Health University. Regarding Tokyo Women's Medical University, the Japanese mass media continue to turn a blind eye to entrance exam brokers and illicit payments amounting to tens of millions of yen. Even in 2025, they still refer to Tokyo Women's Medical University—a well-known backdoor, money-powered institution—as a "prestigious university," featuring comments from insiders who claim its management is topnotch.





Having completed the doctoral program at the Graduate School of Medicine of this university, we hereby confer upon you the degree of Doctor of Philosophy in Medicine (Ph.D. in Medicine).

For instance, my medical and medical education background based on the "National Mie University system" did not align academically with the "Private Kyorin University system" of the hospital. As a result, my employment at a 239-bed long-term care hospital for elderly patients in Chiba Prefecture (part-time since 2014 and full-time since 2016) was terminated as of this month, January 2025. In reality, the male chairperson and hospital director (surgeon), a graduate of Private Kyorin University (Japan) and presumably with medical education costs exceeding 60 million yen (assuming 1 USD = 150 JPY, equivalent to 4,000,000 USD), neither disclosed nor documented his alma mater or the cost of his education. From my perspective as a distinguished physician from National Mie University, it is challenging to have discussions or debates on medical and medical education-related topics with doctors from private universities.

- "The presence of a ward nurse in the hospital who does not follow the medical instructions (work orders) of a physician (a brilliant doctor of medicine from a national university)."
- "The medical issue where, upon hospitalization in a long-term care hospital, the hospital director directly instructed each ward's attending physician regarding the patient's oral medications prescribed by the previous doctor. Subsequently, all doctors (including the hospital director but excluding myself) discontinued all oral medications."
- "The medical environment within the hospital where the male hospital director, presumably a graduate of Private Kyorin University, uses casual speech resembling 'Chatte,' in a manner akin to that of elementary school children, as I observed among graduates of Private Juntendo University, etc. This raises issues related to mannerisms, interpersonal relationships, and professionalism among medical staff. Additionally, regarding the hospital director, I often hear from others within the hospital about his working attitude, such as "looking down" or "from the bottom."
- "Issues related to loose male-female interpersonal relationships and professionalism among doctors and staff members, including the hospital director (excluding myself)"
- "There are issues related to loose male-female interpersonal relationships and morality among doctors and staff members, including the hospital director (excluding myself)."
- "Thankfully, the 3rd-floor ward, where I have served as the attending physician for 60 inpatients over a continuous period of seven years from 2018 to 2024, has consistently maintained the highest evaluation among the hospital's four wards (2F, 3F, 4F, and the South Ward) in its publicly stated commitment to being a 'hospital where patients can receive long-term care with peace of mind." (This evaluation is based on the annual number of patients discharged due to death. The hospital director, who usually does not take charge of any specific ward, served as the attending physician for the South Ward (59 beds) for only two months, February and March of 2024. During that period, the number of patient deaths and discharges in the South Ward was severe.)"

Additionally, I humbly suggested in writing that the hospital should refer to the crisis management measures implemented by esteemed medical institutions, which are regarded as superior even in the Tokyo metropolitan area, such as National Chiba University and JCHO Chiba Hospital, and adopt similar approaches. I believe such actions would also be beneficial from a medical education perspective. For instance, in the past, National Hokkaido University (Japan) once concluded, when deciding on university policies, to "wait and see how (the superior) National Tokyo University handles it" before making their decision. Unfortunately, as of January 16, 2025, this academic advice of mine, conveyed in a written document, was not understood by the two mediocre individuals: the hospital director (a graduate of Private Kyorin University) and the hospital administrator (a graduate of a private university in Gifu Prefecture). 私 Cairo は、1997年に訪れて以来2回目の訪問です。

私 1990 年から 1994 年まで、「全日本卓球 Team の Team Doctor」(非常勤)を拝命させていただきましたが、私からしますと当時在籍中の国立三重大学大学院医学研究科並びに三重大学附属病院、及び三重県内の三重大学関連病院において、1990 年より三医会(三重大学医学部医学科同窓会)の医師からありとあらゆる嫌がらせを受けました。具体的には病院病棟 Nurse Station で、自身カルテ白紙の副病院長(三医会)が、「カルテをちゃんと書かんかー」と私の肩を小突きながら自信たっぷりに怒鳴り、周りの三医会の医師はヘラヘラ笑ってそれを見守っているだけ。その後私の給与を半分に減らし、最終的にはそのカルテ白紙の三医会、垣内雅彦講師(現教授)並びに肝臓 Group の医療、研究を国内の学会で指摘しました医師(Dr.志田)を事実上解雇されました。また当時の三重大学附属病院の病院長(国立東北大学ご出身)と三重大学第三内科教授(三医会)からは、「三医会の医師と、志田先生が勤務中の四日市の病院の国立熊本大学ご出身病院長は、国立大学医学科を合格しており信用出来る。それに比べて「志田先生は、国立三重大学大学院医学研究科を出ているが、国立福島大学教育学部しか合格しておらず信用出来ない。」との様に伺いました。その強い Pressure の元、残念ながら当時の私は、医学書をほぼ買えず、学会にもほぼ出席できず、内科認定医・専門医が取れずの状況で、日本卓球協会での学術 Paper も、とても褒められたものではありませんでした。さらに、田口修 三重大学講師(現教授)の勤務先における違和感のある男女人間関係も、深刻な問題でした。

そして 1997 年に三重県の病院を事実上解雇されました後、私「Hello Work(公共職業安定所:America で相当する機関は『American Job Centers』)」に登録させていただきました。失業保険としていただいた 30 万円は、1997 年 9 月大阪の診療所へ再就職する前の夏に、Cairo への観光旅行の元手となり、「Hallo, Majestic Sphinx」させていただきました。

1997 年 8 月に初めて訪れました Khufu 王の Pyramid 内部では、王の間からの帰路、大回廊から続く上昇通路の中、柵で仕切られた女王の間へ繋がる通路から、欧米人の家族が出てみえまして、Egypt 人 Guide にお札を渡していらっしゃいました。Egypt 人は、その場でお札を目の前で確認され、「No Problem」と言ってみえましたが、私の専門分野、大学不正入試から拝見しますと、学術的に日本の三流私立大学の裏口入試と重なってみえます。私立愛知医大、私立帝京大学、私立東京女子医大などの裏口金権大学でも、Mass Media にほぼ報道されない入試 Broker と裏金が合法的に動いています。Egypt の新聞、TV も、Khufu 王 Pyramid の女王の間への「裏技入場」については合法にて News にしていらっしゃらないかもしれませんが、日本の Mass Media も私立藤田医大の太鼓持ちをしてみえる朝日新聞社と変わりありません。私立東京女子医大に関しても、入試 Broker と何千万円もの裏金には目を瞑り、有名「裏口金権大学」である私立東京女子医大のことを「名門大学」と呼ばれ、「経営は超一流」との関係者の Comment を採用された報道を今年 2025 年も継続してみえます。

また「東京首都圏でも一目置かれ、格上と思われています医療機関、例えば国立千葉大学、JCHO 千葉病院などにおかれます危機管理対応を、僭越ながら見習っていただいて、同じ様なご対応をしていただければ、医学教育的にもよろしいかと存じます。昔 国立北海道大学も、大学の方針決定の際、『(格上の) 国立東京大学の様子を見てから決めましょう』との結論を出されたことがありました」との私からの文書による学術的な Advice も、お二人の凡才、病院長(私立杏林大学ご出身)と病院事務長(岐阜県の私立大学ご出身)には、2025年1月16日、残念ながらご理解いただけませんでした。
